5	\$350,000.00 in program revenue from residential and commercial trash collection,
6	heavy equipment services and the sale of recycling materials; and
7	WHEREAS, the Solid Waste Management Program has prepared a budget amount of \$350,000.00
8	for the 044-13-3525 budget; and
9	WHEREAS, the Solid Waste Management Program Budget 044-13-3525 has been reviewed and
10	approved by the Legislative Agriculture and Natural Resources Committee and the
11	Legislative Budget and Finance Committee.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the
13	expenditure of \$350,000.00 from deposits of program revenue for the Solid Waste
14	Management Program Budget 044-13-3525, from October 1, 2012 through September
15	30, 2013, in accordance with the budget attached hereto.
16	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
17	Chairperson and any designated official to expend and administer the budget as
18	attached, provided that any amendments affecting the funds or funding level is
19	submitted for further prior approval by the Tohono O'odham Legislative Council.
