

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving supplemental funding of \$22,036.00 for the Capital Expenditures to  
purchase an all-terrain vehicle and trailer(s) for accessing illegal migrant and  
smuggler waste on the Tohono O'odham Nation)**

**RESOLUTION NO. 12-233**

1 **WHEREAS, the Tohono O'odham Nation's Solid Waste Management Program has been collecting**  
2 **and disposing of illegal migrant and smuggler waste since 2004, received funding from**  
3 **the US Bureau of Land Management and the U.S. Environmental Protection Agency**  
4 **through a Cooperative Agreement # L08AC14165; and**

5 **WHEREAS, the BLM Cooperative Agreement does not allow for the capital purchase of equipment;**  
6 **and**

7 **WHEREAS, the Solid Waste Management Program is needing to purchase an all-terrain vehicle**  
8 **with both haul trailer and transfer trailer that will have the specifications to get to**  
9 **remote off-road areas so that waste material can be removed safely and efficiently;**  
10 **and**

11 **WHEREAS, the cost for an all-terrain vehicle and transport trailers able to go to remote areas and**  
12 **haul out waste will cost approximately \$22,036.00; and**

13 **WHEREAS, FY2013 supplemental budget has been reviewed by the Agriculture and Natural**  
14 **Resources Committee and the Budget and Finance Committee of the Legislative**  
15 **Council an recommend its approval and adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
17 **approves the Supplemental Budget of \$22,036.00 for the Solid Waste Management**  
18 **Program as one time funding from Tribal Resources.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendments affecting the funds or funding level is**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
24 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
26 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**


