NRD-WVMP-USFWS Tribal Wildlife Grant Budget 700-13-3577 for a total budget  
of \$72,393.52)**

**RESOLUTION NO. 12-234**

1 **WHEREAS, Resolution No. 10-368 approved and accepted the U.S. Fish and Wildlife Services'**  
2 **Tribal Wildlife Grant Award No. AZ U-10-NA-1 in the amount of \$200,000 to inventory**  
3 **the flora and fauna in the Coyote, Quinlan and Baboquivari Mountains, otherwise**  
4 **known as the Baboquivari Mountain Region; and**

5 **WHEREAS, Resolution No. 11-530 approved the Extension of grant period of 10/01/2010 through**  
6 **09/30/2013 and Approving the FY2012 Budget Amount of \$189,872.61; and**

7 **WHEREAS, the Wildlife and Vegetation Management Program is requesting that the FY2013**  
8 **estimated carry forward funds in the amount of \$60,927.05 and indirect cost charge**  
9 **of \$11,466.47 for a total budget of \$72,393.52; and**

10 **WHEREAS, the FY2013 NRD-WVMP-USFWS Tribal Wildlife Grant 700-12-3577 has been reviewed**  
11 **by the Agricultural and Natural Resources Committee and the Budget and Finance**  
12 **Committee of the Legislative Council and recommend its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **in accordance with the budget attached hereto to carry forward estimated FY2012**  
15 **Department of Natural Resources-Wildlife and Vegetation Management Program-U.S.**  
16 **Fish and Wildlife Service in the amount of \$60,927.05 and indirect cost charge of**  
17 **\$11,466.47 for a total budget of \$72,393.52 and to utilize the Nation's resources**  
18 **pending reimbursement from the Grantor for the continuation of the Grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the Budget as**  
21 **attached, provided that any Amendments affecting the funds or funding level is**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
24 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
26 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**

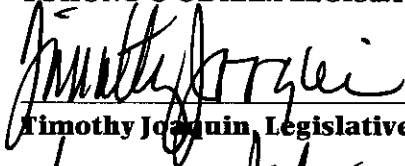

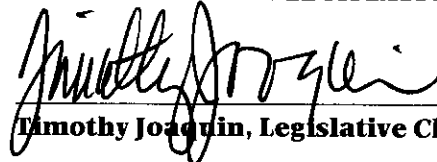
