1 **WHEREAS, the Water Resources Department is requesting \$1,810,317.00 from the Southern**
2 **Arizona Water Rights Settlement Act Trust Fund for the FY2013 budget 021-13-4520;**

4 **WHEREAS, the Water Resources Department is also requesting an in-kind service match of**
5 **\$7,105.00 from the FY2013 budget 021-13-4520 to the Water Resources Department**
6 **FY2013 budget 700-13-4510; and**

7 **WHEREAS, the Water Resources Committee and the Budget and Finance Committee of the**
8 **Legislative Council have reviewed this Budget and recommend its approval and**
9 **adoption.**


10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **authorizes:**

- 12 **1. The appropriation and expenditure of \$1,810,317.00 from the Southern Arizona**
13 **Water Rights Settlement Act Trust Fund for the Water Resources Department**
14 **FY2013 budget 021-13-4520, in accordance with the budget attached hereto.**
- 15 **2. An in-kind service match of \$7,105.00 from the FY2013 budget 021-13-4520 to the**
16 **Water Resources Department FY2013 budget 700-13-4510.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the Budget, as**
19 **attached, provided that any Amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
22 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,576.0 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and 204.60 [05] ABSENT, pursuant to the powers vested in the Council by Article**
24 **VI and XVII, Section 1 (f)(j) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
