8	and has prepared a Supplemental Budget in the amount of \$53,120.00; and
9	WHEREAS, the vehicles currently assigned to the Enrollment Program is costing more each year
10	to maintain and operate; and
11	WHEREAS, the Enrollment Program has presented this Supplemental Budget to the Rules
12	Committee and to the Budget and Finance Committee for review and recommend its
13	approval and adoption.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
15	the Enrollment Supplemental Budget as one time funding in the amount of \$53,120.00.

17	Chairperson and any designated official to expend and administer the budget, as
18	attached, provided that any amendments affecting the funds or funding levels of the
19	budget shall be submitted for further prior approval by the Tohono O'odham
20	Legislative Council.
