3	WHEREAS, the Tohono O'odham Nation Environmental Protection Office (EPO) has submitted a
4	proposal to the U.S. Environmental Protection Agency under the Indian General
5	Assistance Program (GAP) in the amount of \$335,867.00 for continued funding which
6	will be awarded in the Assistance Agreement; and
7	WHEREAS, the GAP Grant is a 4-year continuation grant with a project period that extends from
8	August 1, 2009 through September 30, 2013 which requires annual applications for
9	new funding; and
10	WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the
11	Legislative Council have reviewed this Budget and recommend its approval and
12	adoption; and
13	WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged without
14	a current year IDC authorization letter.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
16	the FY 2013 proposal amount of \$335,867.00 and to utilize the Nations Resources
17	pending reimbursement from the Grantor for the continued funding of the grant.
18	BE IT FURTHER RESOLVED that the Council approves the attached budget that does not include
19	IDC and authorizes the expenditure of funds according to this budget, which shall be
20	in effect from October 1, 2012 to September 30, 2013.
21	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
22	Chairperson and any designated official to expend and administer the budget as
23	attached, provided that any amendments affecting the funds or funding level shall be
24	submitted for further prior approval by the Tohono O'odham Legislative Council.
