

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2013 Brownfields Section 128(a) Budget)

RESOLUTION NO. 12-242

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the environment and**
2 **safe guarding the health and well-being of the Nation's members; and**

3 **WHEREAS, the Tohono O'odham Nation Environmental Protection Office (EPO) has submitted a**
4 **proposal to the U.S. Environmental Protection Agency under the Brownfields Section**
5 **128(a) Tribal Response Program in the amount of \$70,000.00 for continued funding**
6 **which will be awarded in an Assistance Agreement; and**

7 **WHEREAS, the Brownfields Section 128(a) Grant would allow the Program to continue to identify,**
8 **assess and conduct oversight at cleanup activities where contamination exists**
9 **throughout the Nation; and**

10 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**
11 **Legislative Council have reviewed this Budget and recommend its approval and**
12 **adoption; and**

13 **WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged without**
14 **a current year IDC authorization letter.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
16 **the FY 2013 EPA Brownfields Section 128(a) proposal amount of \$70,000.00 and to**
17 **utilize the Nations Resources pending reimbursement from the Grantor for the**
18 **continued funding of the grant.**

19 **BE IT FURTHER RESOLVED that the Council approves the attached budget that does not include**
20 **IDC and authorizes the expenditure of funds according to this budget, which shall be**
21 **in effect from October 1, 2012 to September 30, 2013.**


22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendments affecting the funds or funding level shall be**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
27 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
28 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
29 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
30 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
31 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**






