

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2013 EPA Clean Air Act Budget)

RESOLUTION NO. 12-243

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the environment and**
2 **safe guarding the health and well-being of the Nation's members; and**

3 **WHEREAS, the Tohono O'odham Nation Environmental Protection Office (EPO) has submitted a**
4 **proposal to the U.S. Environmental Protection Agency under the Clean Air Act (CAA)**
5 **Grant in the amount of \$85,000.00 for continued funding which will be awarded in an**
6 **Assistance Agreement; and**

7 **WHEREAS, the Clean Air Act grant would allow the EPO to finalize the Point Source Emissions**
8 **Inventory and Needs Assessment, develop a Monitoring Plan; develop a Quality**
9 **Assurance Project Plan and participation in local, regional and national initiatives;**
10 **and**

11 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**
12 **Legislative Council have reviewed this Budget and recommend its approval and**
13 **adoption; and**

14 **WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged without**
15 **a current year IDC authorization letter.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
17 **the FY 2013 EPA Clean Air Act proposal amount of \$85,000.00 and to utilize the Nations**
18 **Resources pending reimbursement from the Grantor for the continued funding of the**
19 **grant.**

20 **BE IT FURTHER RESOLVED that the Council approves the attached budget that does not include**
21 **IDC and authorizes the expenditure of funds according to this budget, which shall be**
22 **in effect from October 1, 2012 to September 30, 2013.**


23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
28 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
29 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
30 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
31 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
