

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Tribal Employment Rights Office FY - 2013**  
**TERO/EEOC Budget 700-13-5071)**

**RESOLUTION NO. 12-244**

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**  
2 **1978; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is to increase**  
4 **employment of Indians on and near the Tohono O'odham Nation by enforcing Indian**  
5 **Preference in employment, training, contracting, subcontracting and eradicate**  
6 **employment discrimination within the exterior boundaries of the Tohono O'odham**  
7 **Nation; and**

8 **WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office has been**  
9 **supplemented by the Equal Employment Opportunity Commission in the amount of**  
10 **\$26,000.00; and**

11 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono**  
12 **O'odham Tribal Employment Rights Office has been approved by the Office of the**  
13 **Chairman in the amount of \$26,000.00; and**

14 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono**  
15 **O'odham Nation does not allow indirect cost due to a fixed price contract.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
17 **approves the Tribal Employment Rights Office FY 2013 Equal Employment Opportunity**  
18 **Commission Budget in the amount of \$26,000.00 without including indirect cost due**  
19 **to a fixed price contract.**

20 **BE IT FURTHER RESOLVED that the duration of this grant shall commence on October 1, 2012**  
21 **through September 30, 2013.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**  
23 **the Chairperson and any designated official to expend and administer the budget as**  
24 **attached, provided that any amendments affecting the funds or funding level shall be**  
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
27 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
28 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
29 **Section 1 (d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**


