3	WHEREAS, the continued operation of the Tribal Employment Rights Office is to increase
4	employment of Indians on and near the Tohono O'odham Nation by enforcing Indian
5	Preference in employment, training, contracting, subcontracting and eradicate
6	employment discrimination within the exterior boundaries of the Tohono O'odham
7	Nation; and
8	WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office has been
9	supplemented by the Equal Employment Opportunity Commission in the amount of
10	\$26,000.00; and
11	WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono
12	O'odham Tribal Employment Rights Office has been approved by the Office of the
13	Chairman in the amount of \$26,000.00; and
14	WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono
15	O'odham Nation does not allow indirect cost due to a fixed price contract.
16	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
17	approves the Tribal Employment Rights Office FY 2013 Equal Employment Opportunity
18	Commission Budget in the amount of \$26,000.00 without including indirect cost due
19	to a fixed price contract.
20	BE IT FURTHER RESOLVED that the duration of this grant shall commence on October 1, 2012
21	through September 30, 2013.
22	BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes
23	the Chairperson and any designated official to expend and administer the budget as
24	attached, provided that any amendments affecting the funds or funding level shall be
25	submitted for further prior approval by the Tohono O'odham Legislative Council.
