

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation Department of Public Safety Fire Department
Capital Equipment Budget)

RESOLUTION NO. 12-245

1 **WHEREAS, the Tohono O'odham Nation Fire Department apparatus are in need of regular**
2 **replacement in order to maintain adequate response capabilities; and**

3 **WHEREAS, recurring funding was appropriated into the Fire Departments Fiscal Year 2008**
4 **budget by Resolution 07-671; and**

5 **WHEREAS, the process to develop specifications, acquire bids and to build any fire apparatus**
6 **typically extends beyond the fiscal year in which funding is appropriated and a**
7 **standalone budget is required; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative Council**
9 **have reviewed this Budget and recommend its approval and adoption.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **annual recurring funding for the Tohono O'odham Nation Fire Department Capital**
12 **Equipment Budget and appropriates \$250,000.00 for FY 2013, 2014, 2015, 2016 and**
13 **2017, which is hereby approved; provided that:**

- 14 **1. The base budget amount for each fiscal year shall be \$250,000.00.**
- 15 **2. Funds that are not expended in a given fiscal year shall be carried over and may be**
16 **expended in the following fiscal year.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
18 **Chairman and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting funds or funding level shall be**
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
22 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
24 **Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
