6	typically extends beyond the fiscal year in which funding is appropriated and
7	standalone budget is required; and
8	WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative Counci
9	have reviewed this Budget and recommend its approval and adoption.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approve
11	annual recurring funding for the Tohono O'odham Nation Fire Department Capita
12	
13	Equipment Budget and appropriates \$250,000.00 for FY 2013, 2014, 2015, 2016 and
14	2017, which is hereby approved; provided that:
15	1. The base budget amount for each fiscal year shall be \$250,000.00.
16	2. Funds that are not expended in a given fiscal year shall be carried over and may be
	expended in the following fiscal year.
17	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
18	Chairman and any designated official to expend and administer the budget as
19	attached, provided that any amendments affecting funds or funding level shall be
20	submitted for further prior approval by the Tohono O'odham Legislative Council.
