1	WHEREAS, the Tohono O'odham Nation ("Nation") adopted a Water Code effective as of July 1,
2	2011and is currently in the process of implementing the Water Code through the
3	Nation's Water Resources Department; and
4	WHEREAS, the Nation has also made it a priority to study, evaluate, quantify and negotiate its
5	water rights claims in the Gila River Adjudication known as the Sif Oidak water rights
6	claims; and
7	WHEREAS, pursuant to Resolution No. 92-156, two of the priorities for use of the Nation's SAWRSA
8	trust fund are to develop the Nation's Water Code and to promote work on the Sif
9	Oidak water rights claims; and
10	WHEREAS, the Office of Attorney General has prepared a budget for \$300,000 in FY 2013 to be
11	funded from the SAWRSA trust fund to pay attorney fees under a contract with Steven
12	Weatherspoon to assist in implementing the Nation's Water Code, assist with the Sif
13	Oidak water rights claim negotiations, and provide legal services on other water
14	related projects, and to pay for the professional services of the Natural Resources
15	Consulting Engineers, Inc., to study and quantify and participate in negotiations
16	regarding the Sif Oidak water rights claims; and
17	WHEREAS, the proposed budget has been reviewed by the Domestic Affairs, Water Resources, and
18	the Budget & Finance Committees, which recommend approval by the Legislative
19	Council.
20	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Conncil approves the
21	Office of Attorney General budget in the amount of \$300,000 for FY 2013 to be funded
22	from the SAWRSA trust fund for attorney fees and professional services contracts on
23	water related matters.
24	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
25	Chairperson and any designated official to expend and administer the budget as
26	attached, provided that any amendments affecting the funds or funding level shall be
27	submitted for further prior approval by the Tohono O'odham Legislative Council.
