

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Office of Attorney General Supplemental Budget for FY 2013)**

RESOLUTION NO. 12-247

1 **WHEREAS, the Office of Attorney General provides legal advice and representation to all officials,**
2 **agencies, departments, divisions and branches of the Nation's government and**
3 **represents the Nation in all legal proceedings; and**

4 **WHEREAS, the Office of Attorney General requires a supplemental budget in order to fund one**
5 **additional attorney position and to purchase one additional vehicle in order to fully**
6 **and effectively perform its function for the Nation; and**

7 **WHEREAS, the Office of Attorney General has prepared a supplemental budget in the amount of**
8 **\$209,221.97 for FY 2013 which has been reviewed by the Domestic Affairs and the**
9 **Budget and Finance Committees, which recommends approval by the Legislative**
10 **Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **Office of Attorney General supplemental budget in the amount of \$209,221.97 which**
13 **includes the new position of Assistant Attorney General which will be recurring costs**
14 **for Salaries and Fringe and will increase their base Budget.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairperson and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level shall be**
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
20 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
