10	Budget and Finance Committees, which recommends approval by the Legislative Council.

	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
12	Office of Attorney General supplemental budget in the amount of \$209,221.97 which
13	includes the new position of Assistant Attorney General which will be recurring costs
14	for Salaries and Fringe and will increase their base Budget.
15	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
16	Chairperson and any designated official to expend and administer the budget as
17	attached, provided that any amendments affecting the funds or funding level shall be
18	submitted for further prior approval by the Tohono O'odham Legislative Council.
