

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating and authorizing funds for the construction of the San Lucy
non-commercial FM radio station in the amount of \$273,093.53)**

RESOLUTION NO. 12-249

1 **WHEREAS, during the Federal Communication Commission's (FCC) filing window of 2007, the**
2 **Tohono O'odham Nation (Nation) filed an application to construction and operate a**
3 **non-commercial educational FM station (San Lucy Station) to serve the San Lucy**
4 **Community of the San Lucy District; and**

5 **WHEREAS, on October 13, 2011 the Nation received notice that the San Lucy Station was issued a**
6 **provisional construction permit, subject to the final approval of the Republic of**
7 **Mexico; and**

8 **WHEREAS, the construction permit allows the Nation three years in which to build the San Lucy**
9 **Station and begin broadcast; and**

10 **WHEREAS, the management of the Nation's current station, through its engineer, has prepared**
11 **a budget reflecting the estimated costs of constructing the San Lucy Station, the**
12 **budget is attached and incorporated into this resolution by this reference; and**

13 **WHEREAS, the budget provides for the initial operating costs for the San Lucy Station consisting**
14 **of communications, utilities, and insurance, as well as the costs for construction,**
15 **engineering, site preparation and equipment necessary for broadcasting; and**

16 **WHEREAS, the budget, as attached, was presented to the Executive, Cultural Preservation**
17 **Committee and the Budget and Finance Committee for review and recommendation.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
19 **hereby appropriate and authorize the expenditure of \$273,093.53 for the construction**
20 **of the San Lucy Station.**

21 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend these funds**
22 **in accordance to the budget as presented and adopted for the period of October 01,**
23 **2012 through September 30, 2013.**

24 **BE IT FINALLY RESOLVED that the Nation's officials to-wit the Chairman or any other designated**
25 **official are hereby authorized to execute any agreement necessary to expend the grant**
26 **funds provided that any amendments affecting the grant funds or funding level shall**
27 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
29 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
31 **Section 1 (d)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**


