16	WHEREAS,	Tohono O'odham Nation Comprehensive Cancer Prevention and Control Planning
17		grant program has prepared a FY 2012 Budget Amendment No.1 to reflect the award
18		amount of \$225,000.00 by reducing the following line items 6500-Tuition and
19		Registration, 6510-Lodging, 6530-Travel Expense, 6540-Mileage POV, 7220-Mileage
20		GSA, 7300-Advertisement, 7000-Supplies Office, 7005-Supplies Other, 7010-Program
21		Supplies, 7340-Public Relations and indirect cost; and
