

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2012 Sells District-Cowlic Community Budget Amendment No. 1)

RESOLUTION NO. 12-256

1 **WHEREAS, Sells District-Cowlic Community Resolution No. CC-52-11; Sells District Council**
2 **Resolution No. SD-97-11; Legislative Council Resolution No. 11-455 approved the Sells**
3 **District-Cowlic Community Fiscal Year 2012 Budget and its justification; and**

4 **WHEREAS, the Cowlic Community identified the need to amend the FY2012 Budget to address the**
5 **needs of the community; and**

6 **WHEREAS, Cowlic Community has prepared and acquired approvals of the attached budget**
7 **Amendment and its Justification with Cowlic Community Resolution No. CC-35-12;**
8 **Sells District Council Resolution No. SD-44-12; and**

9 **WHEREAS, this Amendment will increase the amounts line items -778 Alteration/Renovation; -779**
10 **Construction; -860 Special Activities; -861 Miscellaneous; and**

11 **WHEREAS, the increase will reduce the budgeted amounts for Line Items -612 Occasional**
12 **Appointments; -630 Insurance; -712 Gas, Oil & Coolants; -774 Computer Maintenance.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **Sells District-Cowlic Community Fiscal Year 2012 Budget Amendment No. 1 of the**
15 **Gaming Revenues by increasing line item -778 Alteration/Renovation by \$10,000; -779**
16 **Construction by \$10,000; -860 Special Activities by \$3,000; -861 Miscellaneous by \$3,000**
17 **which will reduce Line Items -612 Occasional Appointments by \$20,000; -630 Insurance**
18 **by \$3,000; -712 Gas, Oil & Coolants by \$1,000.00; -774 Computer Maintenance by \$2,000.**

19 **BE IT FURTHER RESOLVED that this Amendment does not affect the approved Cowlic Community**
20 **FY 2012 Budget of \$173,500 or the overall Sells District Fiscal Year 2012 Budgeted**
21 **amount of \$1,660,996.79.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
23 **District Chairperson and any designated District Official to expend and administer the**
24 **budget, as attached, provided that any modifications or amendments affecting the**
25 **funds or funding levels of the budget shall be submitted for further prior approval by**
26 **the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day**
28 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
29 **[01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
30 **Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
31 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
