10	Gaming Revenue interest account from the Tohono O'odham Nation Treasury; and
11	WHEREAS, the additional amount of \$33,201.00 will increase the Sif-Oidak District
12	Administration Budget from \$1,385,804.70 to \$1,419,005.79; and
13	WHEREAS, the additional amount of \$33,201.00 will also increase the FY 2012 Sif-Oidak District
14	Gaming Revenue Budget from \$1,660,996.79 to \$1,694,197.70; and
15	WHEREAS, the Budget and Finance Committee did review the FY 2012 Sif-Oidak District
16	Administration Budget Amendment #1 on June 18, 2012 and recommends approval.
17	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council, that it does
18	hereby approve the FY 2012 Sif-Oidak District Administration Budget Amendment #1
19	in the amount of \$33,201.00.
20	BE IT FURTHER RESOLVED that the \$33,201.00 will come out of the Sif-Oidak District Gaming
21	Interest dollars held by the Nation.
22	BEIT FURTHER RESOLVED that the FY 2012 Sif-Oidak District Administration Budget will increase
23	from \$1,385,804.70 to \$1,419,005.79.
24	BE IT FURTHER RESOLVED that the FY 2012 Sif-Oidak District Administration Budget will also
25	increase from \$1,660,996.79 to \$1,694,197.70.
26	BE IT FINALLY RESOLVED that in the event there should be any further changes,
27	Amendments/Modifications that it shall be approved by the Tohono O'odham
28	Legislative Council prior to any expenditures.
