1 **WHEREAS, the Tohono O'odham Legislative Council on September 26, 2011, passed Resolution No.**
2 **11-451, "Approving the FY 2012 Sif-Oidak District Gaming Revenue Budget in the**
3 **amount of \$1,660,996.79"; and**

4 **WHEREAS, the Sif-Oidak District Council, passed Resolution No. SODC-12-041 "Approving the FY**
5 **2012 Sif-Oidak District Senior Services Budget Amendment #1 in the amount of**
6 **\$1,080.87 at a special meeting held on March 28, 2012; and**

7 **WHEREAS, amendment #1 is transferring funds between line items in the amount of \$1,080.87,**
8 **specifically from Line Items (650) Registration - \$580.87; and (850) Consumables-**
9 **\$500.00 into Line Item (614) Temporary Labor - \$1,080.87; to cover the over-**
10 **expenditure for the remainder of the Fiscal Year; and**

11 **WHEREAS, the Legislative Budget & Finance Committee did review the FY 2012 Sif-Oidak District**
12 **Senior Services Budget Amendment #1 on March 19, 2012 and recommends approval.**


13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council, that it does**
14 **hereby approve the Sif-Oidak District FY 2012 Sif-Oidak District Senior Services Budget**
15 **Amendment #1 in the amount of \$1,080.87.**

16 **BE IT FURTHER RESOLVED that the Amendment #1 does not reflect any changes to the budget**
17 **amount.**

18 **BE IT FINALLY RESOLVED that in the event there should be any amendments/modifications in the**
19 **funding or funding levels that it shall be approved by the Tohono O'odham Legislative**
20 **Council prior to any expenditures.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day**
22 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
24 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**
