**RESOLUTION NO. 12-261**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2012 Enrollment Committee**  
2 **Budget, in the amount of \$49,250.00 with Resolution No. 11-320; and**

3 **WHEREAS, the Enrollment Program Office is requesting the Tohono O'odham Legislative Council**  
4 **to add line item 7355 Professional Services to the FY 2012 Enrollment Committee**  
5 **Budget and approve funds to use for interpreter for the rejection and revocation**  
6 **hearings; and**

7 **WHEREAS, this budget amendment has been reviewed by the Executive Office, Rules Committee**  
8 **and Budget & Finance all of which recommend approval by the Tohono O'odham**  
9 **Legislative Council.**


10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
11 **approves and authorizes Budget Amendment No.1;**

- 12 **1. Decrease line item 6500 Training Fees and Registration and adding line item 7355**  
13 **Professional Services.**
- 14 **2. Budget remains as approved at \$49,250.00.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
16 **the Chairman and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
20 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
21 **[01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
22 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**






