

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amendment No. 1 for the FY 2012 Ranger Program Budget for a retro payment to a Ranger for a Senior Ranger Position to be taken from salary savings and to adjust the Indirect Cost Rate)**

RESOLUTION NO. 12-271

- 1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the 638 BIA Master Contract; and**
- 3 **WHEREAS, in FY 2010 one of TOPD's Ranger's successfully completed the Indian Police Academy**
4 **in May 2010 and was promoted from a Ranger to Senior Ranger (Ranger II) position,**
5 **however, did not capture the Senior Ranger salary until August 5, 2010; and**
- 6 **WHEREAS, in FY 2010 the Tohono O'odham Nation Police Department attempted to bring forward**
7 **a budget amendment to include the reclassification of two positions from Ranger to**
8 **Senior Ranger, however, the request was put on hold until the Tohono O'odham Nation**
9 **Tri-Branch Pay Plan was completed and Wage survey being presented to the**
10 **Legislative Council; and**
- 11 **WHEREAS, the TONPD requests to amend its FY 2012 Ranger program budget to accommodate the**
12 **retro payment to the Ranger for the period beginning of 5/7/2010 through 8/7/2010 at**
13 **the rate of a Senior Ranger salary in the amounts of \$3,780.36 for salary and \$1,010.23**
14 **for fringe benefits for a total net payment of \$2,770.13; and**
- 15 **WHEREAS, the retro payment will be taken from salary savings under the FY 2012 '638 Ranger**
16 **Program Budget line items 6000 Salaries and 6200 Fringe Benefits; and**
- 17 **WHEREAS, the additional retro payment will be added to the Senior Ranger's annual salary; and**
- 18 **WHEREAS, with this retro payment the FY 2012 638 Ranger Program base budget will not change;**
19 **and**
- 20 **WHEREAS, this budget amendment No. 1 shall also increase the Indirect Cost rate from 16.82%**
21 **to \$18.82%, increasing indirect cost in the amount of \$19,296.06, for a total budget**
22 **increase from \$1,127,083.03 to \$1,146,379.09; and**
- 23 **WHEREAS, the FY 2012 638 Ranger Program Budget Amendment No. 1 has been reviewed by the**
24 **budget office, Grants & Contracts, Executive, Domestic Affairs and Budget & Finance**
25 **which all recommend its approval.**
- 26 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
27 **approves and authorizes Budget Amendment No. 1 for FY 2012 '638 Ranger program**
28 **as follows:**
- 29 **1. Retropayment beginning 5/07/2010 to 8/7/2010 to include \$3,780.36 in Salaries and**

- 1 **\$1,010.23 in Fringe Benefits for a total net payment of \$2,770.13.**
- 2 **2. Increase the Indirect Cost rate from 16.82% to 18.82% increasing the total**
- 3 **approved budget in the amount of \$19,296.06 from \$1,127,083.03 to \$1,146,379.09.**

4 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that it hereby authorizes
5 **the Chairman and any designated official to expend and administer the budget as**
6 **attached, provided that any amendments affecting the funds or funding level shall be**
7 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
9 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
10 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
11 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
12 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
13 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




