10	WHEREAS,	the U.S. Department of Health and Human Services, Administration for Children and
11		Families (ACF), has notified the Department that The Child and Family Services
12		Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%
13		starting October 1, 2007 for these Title IV -B budgets; and
14	WHEREAS,	the Title IV B budget appropriations are authorized for a two year expenditure period, and are appropriate appropriation and appropriation appropriate appropriation approximately approximate
15		$beginning\ October\ 1,2011\ and\ ending\ September\ 30,2013, to\ cover\ two\ fiscal\ years\ FY$
