

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2012 Department of Health & Human Services Title IVB
Subpart 2 budget Amendment #1 for Division of Child Welfare)

RESOLUTION NO. 12-278

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health & Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**
4 **of Child Welfare Services to intervene against child abuse and neglect and to promote**
5 **safe and stable families; and**

6 **WHEREAS, Title IV B, Subpart 2 grants require a 25% match, which the Nation matches through**
7 **the P.L. 93-638 master contract, specifically the BIA Social Services budget for child**
8 **welfare services and the BIA ICWA budget for Family Preservation Program, as**
9 **authorized by both P.L. 93-638 and the Department of Health & Human Services; and**

10 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**
11 **Families (ACF), has notified the Department that The Child and Family Services**
12 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%**
13 **starting October 1, 2007 for these Title IV -B budgets; and**

14 **WHEREAS, the Title IV B budget appropriations are authorized for a two year expenditure period,**
15 **beginning October 1, 2011 and ending September 30, 2013, to cover two fiscal years FY**
16 **2012 and FY 2013; and**

17 **WHEREAS, Title IV B, Subpart 2 Budget 300-12-6055 by resolution #11-245 approved \$251,601.00**
18 **and the award amount for FY 2012 is \$226,273.00 decreasing the budget by \$25,328.00;**
19 **and**

20 **WHEREAS, decreasing line items 6500 Tuition and Registration, 6510 Lodging, 6530 Travel**
21 **Expense, 7005 Supplies-Other, 7010 Program Supplies, 7420 RM Building, 7355**
22 **Professional Services and 7665 Client Support; and**

23 **WHEREAS, the Department of Health & Human Services is in receipt of the Notice of Award as Title**
24 **IV-B, Subpart 2 Budget 300-12-6055 with the restricted 10% IDC changing the amount**
25 **from \$20,781.91 to \$19,772.55 with a decrease of \$1,009.36; and**

26 **WHEREAS, the Executive Office, the Health and Human Service Oversight Committee and the**
27 **Budget & Finance Committee of the Legislative Council have reviewed this Budget and**
28 **recommend its approved and adoption.**



2 **the FY 2012 Department of Health and Human Services Title IV-B, Subpart 2 Budget**
3 **amendment #1 to adjust the Indirect Cost to reflect the restricted 10% and award**
4 **amount of \$226,273.00.**

5 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
6 **Chairman and any designated official to expend and administer the budget, as**
7 **attached, provided that any amendments affecting the funds or funding level shall be**
8 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
10 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
11 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
12 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
15 **Stat. 984).**






