5	ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and
6	WHEREAS, the Legislative Branch FY 2012 budget was approved by Resolution No. 11-321; and
7	WHEREAS, the Legislative Branch administration has prepared and submitted for review and
8	approval its FY 2012 Budget Amendment No. 2 in the amount of \$224,196.88; and
9	WHEREAS, the FY 2012 Legislative Branch Budget Amendment No. 2 has been reviewed by the
10	Budget and Finance Committee.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
12	
13	FY 2012 Legislative Branch Budget Amendment No. 2, which does not change the base budget amount of \$3,449,361.71.
14	
	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
15	Nation Legislative Council Chairman and Vice-Chairman are authorized to administer
16	the attached budget, provided however, that any amendments affecting these funds
17	or funding levels budgeted shall be submitted for prior approval by the Tohono
18	O'odham Legislative Council.
