

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2012 Legislative Branch Budget Amendment No. 2)**

**RESOLUTION NO. 12-280**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these funds**  
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**  
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Branch FY 2012 budget was approved by Resolution No. 11-321; and**

7 **WHEREAS, the Legislative Branch administration has prepared and submitted for review and**  
8 **approval its FY 2012 Budget Amendment No. 2 in the amount of \$224,196.88; and**


9 **WHEREAS, the FY 2012 Legislative Branch Budget Amendment No. 2 has been reviewed by the**  
10 **Budget and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **FY 2012 Legislative Branch Budget Amendment No. 2, which does not change the base**  
13 **budget amount of \$3,449,361.71.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation Legislative Council Chairman and Vice-Chairman are authorized to administer**  
16 **the attached budget, provided however, that any amendments affecting these funds**  
17 **or funding levels budgeted shall be submitted for prior approval by the Tohono**  
18 **O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
20 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
22 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
