(Approving Ali Chugk Community FY'2012 Budget Amendment No. 3 to Carry  
Over FY'2009 into FY'2012 in the amount of \$5,040.00)**

**RESOLUTION NO. 12-282**

1 **WHEREAS, the Ali Chugk Community/Gu-Vo District is requesting amendment to the FY'2012**  
2 **Budget in order to conduct business at their community level; and**

3 **WHEREAS, the Ali Chugk Community of Gu-Vo District did review the needs of the Community, in**  
4 **carrying over from FY'2009 to add funds in areas that need additional funding; 7100**  
5 **-Utilities: Increased to provide payment for Solid Waste delinquent bills for**  
6 **community members for FY'2011 and FY'2012; and**

7 **WHEREAS, the Ali Chugk Community Budget for FY'2012 has been increased in the amount of**  
8 **\$5,040.00; grand total for Fiscal Year 2012 is in the amount of \$383,819.10; and**

9 **WHEREAS, the proposed amendments from the Ali Chugk Community has gone through proper**  
10 **reviews from the Gu-Vo District; and**

11 **WHEREAS, the Ali Chugk Community/Gu-Vo District did submit their FY' 2012 Budget Amendment**  
12 **No. 3 to Carry Over FY' 2009 into FY' 2012 in the amount of \$5,040.00 to the Tohono**  
13 **O'odham Legislative Council Budget & Finance Committee for review and**  
14 **recommendation; and**

15 **WHEREAS, the Legislative Council Budget & Finance Committee does hereby recommend**  
16 **approval to the Ali Chugk Community FY' 2012 Budget Amendment No. 3 to Carry Over**  
17 **FY' 2009 into FY' 2012 in the amount of \$5,040.00; and**

18 **WHEREAS, the Gu-Vo District FY' 2012 Budget has been increased in the \$5,040.00; grand total for**  
19 **the Gu-Vo District FY' 2012 Budget is in the amount of \$2,297,144.69.**

20 **NOW, THEREFORE, BE IT RESOLVED that that Tohono O'odham Legislative Council hereby**  
21 **approves the Ali Chugk Community FY' 2012 Budget Amendment No. 3 to Carry Over**  
22 **FY' 2009 into FY' 2012 in the amount of \$5,040.00; 7100 -Utilities: Increased to provide**  
23 **payment for Solid Waste delinquent bills for community members for FY'2011 and**  
24 **FY'2012.**

25 **BE IT FURTHER RESOLVED that the Gu-Vo District current budget for FY' 2012 is in the amount of**  
26 **\$2,292,104.69, increased in the amount of \$5,040.00, with a total for Gu-Vo District**  
27 **Budget for FY' 2012 is \$2,297,144.69.**

7 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
8 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
9 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
10 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
12 **Stat. 984).**


