

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Tribal Employment Rights Ordinance Commission**  
**TERO Fee Budget #044-13-8500 at \$360,079.99 for FY 2013)**

**RESOLUTION NO. 12-290**

1 **WHEREAS, the Tohono O'odham Nation adopted the Employment Rights Ordinance No. 01-85**  
2 **which established the Tribal Employment Rights Ordinance Commission, who was**  
3 **charged with carrying out the terms of the Ordinance; and**

4 **WHEREAS, the independent Commission functions in the applications of preference in**  
5 **contracting and employment under the TERO Ordinance No. 01-85; as amended, 13**  
6 **T.O.C. Chapter 1; and**

7 **WHEREAS, the Tribal Employment Rights Ordinance Commission is assisted by the Tribal**  
8 **Employment Rights Office, which has operated since 1978; and**

9 **WHEREAS, the Employment Rights Ordinance provides, in Section 11 for the collection of**  
10 **Employment Rights TERO Fees from all covered employers operating within the**  
11 **exterior boundaries of the Nation; and**

12 **WHEREAS, the purpose of the TERO Fees is to raise revenue for the operation of the Tribal**  
13 **Employment Rights Ordinance Commission; and**

14 **WHEREAS, in accordance with Section 11 ( C ) of the Ordinance, the TERO fees collected shall be**  
15 **expended by the Tribal Employment Rights Ordinance Commission pursuant to**  
16 **budgets duly approved by the Executive Office and Legislative Council to carry out the**  
17 **purposes of the Ordinance, including training programs for workers and business**  
18 **persons; and**

19 **WHEREAS, the Tribal Employment Rights Ordinance Commission submits FY 2013 budget in the**  
20 **amount of \$360,079.99 from the remaining TERO fees collected; and**

21 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**  
22 **Legislative Council have reviewed this Budget and recommend its approval and**  
23 **adoption.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
25 **approves the Tribal Employment Rights Ordinance Commission FY-2013 Budget in the**  
26 **amount of \$360,079.99 for a grand total of \$360,079.99 attached hereto.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorize the**  
28 **Tribal Employment Rights Ordinance Commission and any designated official to**  
29 **expend and administer the budget as attached, provided that any amendments**  
30 **affecting funds or funding levels shall be submitted for further prior approval by**  
31 **Tohono O'odham Legislative Council.**


