

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Tribal Employment Rights Commission TERO**  
**Fee Amendment 044-12-8500-7500 at \$17,500.00 FY2012)**

**RESOLUTION NO. 12-291**

1 **WHEREAS, the Tohono O'odham Nation adopted the Employment Rights Ordinance No. 01-85**  
2 **which established the Tribal Employment Rights Commission, who was charged with**  
3 **carrying out the terms of the Ordinance; and**

4 **WHEREAS, the independent Commission functions in the applications of preference in**  
5 **contracting and employment under the TERO Ordinance No. 01- 85; as amended, 3**  
6 **T.O.C. Chapter 1; and**

7 **WHEREAS, the Tribal Employment Rights Commission requests use of major capital equipment**  
8 **funds be decreased in the amount of \$15,000.00 and applied to professional services**  
9 **line item increasing current budget of \$2,321.84 which a total of \$17,321.84 to**  
10 **professional services; and**

11 **WHEREAS, the Tribal Employment Rights Commission justification for increasing the**  
12 **professional services line item to continue to provide services to TERO Clientele with**  
13 **services such as janitorial services; catering services; training TERO Office personnel**  
14 **and TERO Commissioners with adequate training and skills through the remainder**  
15 **of FY 2012; and**

16 **WHEREAS, the Tribal Employment Rights Commission submits FY 2012 budget amendment to**  
17 **increase line item 7005 supplies other current balance of \$609.87 and decreasing**  
18 **major capital expenditure of \$2,500.00; and**

19 **WHEREAS, the Tribal Employment Rights Commission justification for increase of supplies other**  
20 **- to purchase communication equipment for clientele; and**

21 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**  
22 **Legislative Council have reviewed this Budget amendment and recommend its**  
23 **approval.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
25 **approves the Tribal Employment Rights Commission FY-2012 Budget amendment in**  
26 **the amount of \$17,500.00 for a grand total of \$17,500.00 attached hereto.**

27 **BE IT FURTHER RESOLVED the Tohono O'odham Legislative Council that it hereby approves the**  
28 **Tribal Employment Rights Commission FY2012 budget modification of \$3,000.00**  
29 **decrease from Alteration & Renovations increase Communication expense of**  
30 **\$3,000.00; Decrease of \$2,500.00 and increase Tuition and Registration of \$2,500.00.**

2 **Tribal Employment Rights Commission FY2012 budget modification of \$3,000 decrease**  
3 **from Alteration & Renovations increase Communication expense of \$3,000.00;**  
4 **decrease of \$2,500.00 and increase Tuition and Registration of \$2,500.00.**

5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council authorizes the Chairperson  
6 **and any designated official to expend and administer the budget as attached, provided**  
7 **that any amendment affecting the funds or finding level shall be submitted for further**  
8 **prior approval by the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
10 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
11 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
12 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
15 **Stat. 984).**
