16 **amendment/modification #1, as presented.**


17 **BE IT FURTHER RESOLVED that this budget amendment/modification #1 does not affect the**

20 **BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications**  
21 **shall be reviewed and approved by the Budget & Finance Committee and the Tohono**  
22 **O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
24 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
26 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**


