**RESOLUTION NO. 12-298**

1 **WHEREAS, the Sif-Oidak District Council, on August 11, 2011 passed Resolution No. SODC-11-147,**  
2 **“Approving the Second Eight-Year Appraisal of the Arizona Public Service (APS), 230**  
3 **KV Transmission Line Right-of-Way prepared by Mr. Dennis L Lopez, MAI, SRA, of**  
4 **Dennis L. Lopez & Associates, LLC and approved by the Department of Interior, Office**  
5 **of the Special Trustee Office of Appraisal Services”; and**

6 **WHEREAS, the APS funding in the amount of \$128,325.00, is a one-time funding which is derived**  
7 **from the second eight-year Appraisal of the APS 230 KV Transmission Line Right-of-**  
8 **Way approved on April 25, 2011; and**

9 **WHEREAS, the Arizona Public Service did make arrangements for the distribution of the**  
10 **compensation in the amount of \$128,325.00; and**

11 **WHEREAS, the Sif-Oidak District Council, on March 28, 2012, passed Resolution No. SODC-12-039,**  
12 **“Approving to Budget the Arizona Public Service (APS) Funds for the Holiday Bonus,**  
13 **Clothing Assistance and District Building Renovation”.**


14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O’odham Legislative Council, that it does**  
15 **hereby approve the Sif-Oidak District Arizona Public Service (APS) Budget in the**  
16 **amount of \$128,325.00.**

17 **BE IT FURTHER RESOLVED that the Budget will be retroactive to December 1, 2011.**

18 **BE IT FINALLY RESOLVED that should there be any changes in the funding or funding levels that**  
19 **prior approval is required by the Tohono O’odham Legislative Council for any**  
20 **expenditure.**

21 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 12<sup>TH</sup> Day**  
22 **of JULY, 2012 at a meeting at which a quorum was present with a vote of 2,304.90 FOR; -0- AGAINST;**  
23 **475.70[02] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
24 **1 (d)(2) of Article VI of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**  
25 **O’Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
