## LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Setting August 13, 2012 Special Session to Address the Nation's Proposed Building Codes)

LEGISLATIVE ORDER NO. 12-300

1	WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2	regulate all meetings of the Tohono O'odham Council, standing committees, boards
3	and special committees." (Constitution of the Tohono O'odham Nation, Article VI
4	Section 1(a)); and
5	WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with
6	the authority to "by majority vote, call for a special session" (Legislative Rules of the
7	Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and
8	WHEREAS, the Housing Committee has requested a special session on August 13, 2012 to address
9	the Nation's proposed Building Codes.
10	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a
11	special session on August 13, 2012 to address the Nation's proposed Building Codes.

13	ILLY, 2012 at a meeting at which a quorum was present with a vote of 2,780,60 FOR - 0- ACAINST.
