

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2013 Arizona Department of Economic Security Planned
Social Services Title XX Block Grant Budget)

RESOLUTION NO. 12-307

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through funding provided by the Arizona**
3 **Department of Economic Security's (A.D.E.S.) Planned Social Services Block Grant**
4 **(S.S.B.G.) Title XX Program; and**

5 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young**
6 **members by providing for their welfare through various programs and services**
7 **designed to meet their special needs; and**

8 **WHEREAS, the Arizona Department of Economic Security has negotiated a cost-reimbursement**
9 **Intergovernmental Agreement, for a five year term from 2009 to 2013 with the Tohono**
10 **O'odham Nation for an Arizona Department of Economic Security Planned Social**
11 **Services Title XX Block Grant in which the Nation will receive full reimbursement for**
12 **all Title XX expenses; and**

13 **WHEREAS, the Arizona Department of Economic Security Planned Social Services Title XX Block**
14 **Grant Budget for FY2013 has been created; and**

15 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
16 **committee of the Legislative Council have reviewed this Budget and recommend its**
17 **approval and adoption.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
19 **approve and authorize the Arizona Department of Economic Security Planned Social**
20 **Services Title XX Block Grant Budget for fiscal year 2013 in the amount of \$116,258.00**
21 **and to utilize the Nations Resources pending reimbursement from the Grantor for the**
22 **continuation of the Grant.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the Budget as**
25 **attached, provided that any Amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
28 **of AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
