

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2012 638 Law Enforcement Budget Amendment 3)**

RESOLUTION NO. 12-309

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) is amending its FY 2012**
4 **budget to cover the cost of the annual Fire Fighter and Peace Officer Cancer Insurance**
5 **cost under the Public Safety Personnel Retirement System; and**

6 **WHEREAS, Amendment #3 will decrease line item 7345 Consultants and increase line item 7305**
7 **Insurance; and**

8 **WHEREAS, this budget amendment has increased the Indirect Cost; and**

9 **WHEREAS, this budget amendment has been reviewed by the Budget Office, Grants & Contracts,**
10 **Executive Office, Domestic Affairs Committee and Budget & Finance all of which**
11 **recommend approval by the Tohono O'odham Legislative Council; and**


12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **approves and authorizes Budget Amendment No. 3;**

- 14 **1. Cover the cost of the annual Fire Fighter and Peace Officer Cancer Insurance.**
- 15 **2. Decreasing line item 7345 Consultants and increasing line item 7605 Insurance.**
- 16 **3. Increasing the Indirect Cost**
- 17 **4. Changing the total budget amount from \$5,433,939.74 to \$5,434,222.04.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
19 **the Chairman and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall be**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
23 **of AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (d)(3) & (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
