9	WHEREAS, the Hikiwan District Council has presented the attached FY2013 Budgets to the
10	Legislative Budget & Finance Committee for review and recommendation of the
11	amount of \$1,241,979.33 for District Admin/Operations and the Seven Communities.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
13	the Hikiwan District FY2013 Budget in the amount of \$961,979.33 for Hikiwan District
14	Admin/Operations; and \$280,000 for the seven communities for a total budget of
15	\$1,241,979.33.
16	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
17	Chairperson and any designated official to expend and administer the budgets as
18	attached, provided that any amendments/modifications affecting the funds or funding
19	levels shall be submitted for further prior approval by the Tohono O'odham
20	Legislative Council.
