

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY2013 Budgets in the Amount of \$1,241,979.33 for the Hikiwan District Administration/Operations and the Seven Communities of Hikiwan District)**

**RESOLUTION NO. 12-315**

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution has apportioned to Hikiwan**  
2 **District from the FY2013 Gaming Revenues the Equal Distribution amount of**  
3 **\$1,202,479.84, and 15% of the Host Share in the amount of \$39,499.49 for a total of**  
4 **\$1,241,979.33; and**

5 **WHEREAS, the Hikiwan District Council Resolution No. HDC-12-053 is attached approving the**  
6 **FY2013 Budget for the District Admin/Operations at \$961,979.33 for Hikiwan District**  
7 **Administration/Operations; and \$280,000 for the seven Communities for a total of**  
8 **\$1,241,979.33; and**

9 **WHEREAS, the Hikiwan District Council has presented the attached FY2013 Budgets to the**  
10 **Legislative Budget & Finance Committee for review and recommendation of the**  
11 **amount of \$1,241,979.33 for District Admin/Operations and the Seven Communities.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **the Hikiwan District FY2013 Budget in the amount of \$961,979.33 for Hikiwan District**  
14 **Admin/Operations; and \$280,000 for the seven communities for a total budget of**  
15 **\$1,241,979.33.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the budgets as**  
18 **attached, provided that any amendments/modifications affecting the funds or funding**  
19 **levels shall be submitted for further prior approval by the Tohono O'odham**  
20 **Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
22 **of AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,658.15 FOR; 122.45**  
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**  
25 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
