

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Fiscal Year 2013 Budgets for Sells District Administration and  
its Communities in the amount of \$1,202,479.84)**

**RESOLUTION NO. 12-320**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 12-206 approved the FY 2013**  
2 **District Allocation and Apportionment of Gaming Revenues to Districts by Equal**  
3 **Distribution in the amount of \$1,202,479.84 to each of the eleven Districts of the**  
4 **Tohono O'odham Nation; and**

5 **WHEREAS, the District was informed that for FY2013 that the Tohono O'odham Legislative Council**  
6 **did not appropriate any Desert Diamond Savings to Supplement the FY 2013 Projected**  
7 **Revenues resulting in a decreased allocation for Fiscal Year 2013; and**

8 **WHEREAS, Sells District Administration did inform the communities of the decrease in funding**  
9 **and requested that all communities begin FY2013 with base budgets of \$75,000 each;**  
10 **and**

11 **WHEREAS, all the Community and District Administration Budgets were presented to each of the**  
12 **four communities and to the Sells District Council for their review and approval; and**

13 **WHEREAS, all communities except for Sells Community did prepare and submit the attached**  
14 **community approved budgets in accordance to their needs; and**

15 **WHEREAS, Sells District Council did review and approve the FY 2013 Sells District Administration**  
16 **Budget and the Community budgets with Sells District Resolution No. SD-62-12; and**

17 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee and the Tohono**  
18 **O'odham Legislative Council did review Sells District Administration Budget and the**  
19 **budgets for each of the four communities.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Sells**  
21 **District Fiscal Year 2013 Budget for Administration and it's communities as submitted**  
22 **in the attached budgets and it's justifications to be effective October 1, 2012 according**  
23 **to the following:**
