1	WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the
2	authority "to promote, protect and provide for public health, peace, morals, education
3	and general welfare of the Tohono O'odham Nation and its members" and with the
4	authority to "consult with the Congress of the United States and appropriate federal
5	agencies regarding federal activities that affect the Tohono O'odham Nation.
6	."(Constitution, Article VI, Section 1(c)(2) and Section 1(j)); and
7	WHEREAS, as part of the Affordable Care Act, the Indian Health Care Improvement Act was
8	permanently reauthorized and contains new provisions concerning health care
9	facility construction priorities, methodology, innovation, and demonstrations
10	including the authorization of a 14 member Facilities Appropriation Advisory Board
11	("FAAB"); and
12	WHEREAS, in a July 3, 2012 letter to tribal leaders, Indian Health Service Director Dr. Yvette
13	Roubideaux asked for member nominations to FAAB; and
14	   WHEREAS,   Jennie F. Becenti, director of the Nation's Department of Health and Human Services
15	has the educational background, health care expertise, and understanding of triba
16	needs to effectively represent the Nation's members and other tribal members; and
17	WHEREAS, the Health and Human Services Committee recommends nominating Director Jennic
18	F. Becenti to the Facilities Appropriation Advisory Board.
19	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it nominates
20	Director Jennie F. Becenti to the Facilities Appropriation Advisory Board.
