1 **WHEREAS, the Tohono O'odham Legislative Council did convene on August 08, 2012 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on July 21, 2012, at a regularly scheduled meeting, the Gu Achi District Council passed**
4 **Resolution #1207-267 for approval of the Fiscal Year 2013 Budgets for the District's**
5 **Administration and Communities for operational and direct services to meet the**
6 **needs of the District and Communities; and**

7 **WHEREAS, the Gu Achi District Fiscal Year 2013 budget was presented, reviewed and**
8 **recommended for approval by the Tohono O'odham Legislative Council's Budget and**
9 **Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**
11 **hereby approve the Gu Achi District's Fiscal Year 2013 Budget in the amount of**


