2	${f intergovernmentalagreement}$ (IGA) under which the Nation receives funds for specific
3	Workforce Investment Act (WIA) employment and training programs operated by the
4	Education Department's One Stop Division (Contract No. DE111026-001); and
5	WHEREAS, amendment no. 3 has been received to extend the term of the IGA from June 30, 2013
6	to August 31, 2015, and incorporates FY13 funding to set the new reimbursement
7	ceilings for grant funding, and to add certain provisions required by the U.S.
8	Department of Labor; and
9	WHEREAS, pursuant to the IGA, the Arizona Department of Economic Security has allocated funds
10	to the Nation for FY2013 in the amount of \$256,254.00 for the period beginning April
11	1, 2012 to August 31, 2014; and
12	WHEREAS, the Domestic Affairs Committee, Human Resources Development Committee and the
13	Budget & Finance Committee have reviewed the IGA, the Arizona Department of
14	Economic Security Amendment No. 3 and recommends Legislative Council approval.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
16	and authorizes Amendment No. 3 and to the Intergovernmental Agreement between
17	the Nation and the Arizona Department of Economic Security substantially in the
18	forms attached hereto, and authorizes the Chairman of the Tohono O'odham Nation
19	to execute it.
