

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Intergovernmental Agreement GRA-RC026-13-0539-01 and Budget**  
**with Arizona Early Childhood Development and Health Board (First Things First)**  
**and the Tohono O'odham Nation)**

**RESOLUTION NO. 12-326**

1 **WHEREAS, the Tohono O'odham Nation recognizes and prioritizes the importance of health,**  
2 **education and general wellbeing of the children of the Tohono O'odham Nation; and**

3 **WHEREAS, the First Thing First initiative was passed by Arizona Voters in 2006 via proposition 203**  
4 **which increases the quality and access to early childhood programs that will ensure**  
5 **all Arizona children enter school healthy and ready to learn; and**

6 **WHEREAS, the Tohono O'odham Nation recognizes specific areas of need in the Division of Special**  
7 **Needs for which funding may be allocated to the Nation through the proposed**  
8 **Intergovernmental Agreement and budget in the amount of \$70,000.00 with an IDC**  
9 **amount of \$3,900.00 as attached with the First Things First organization; and**

10 **WHEREAS, the First Things First Intergovernmental Agreement shall commence on July 1, 2012**  
11 **and remain in effect until June 30, 2013, and may be renewed for two additional twelve**  
12 **month periods until June 30, 2015, based on performance and availability of funds;**  
13 **and**

14 **WHEREAS, the Grants & Contracts Office, Executive Office, the Health and Human Services, the**  
15 **Budget & Finance and Domestic Affairs Committees of the Legislative Council have**  
16 **reviewed the First Things First Intergovernmental Agreement GRA-RC026-13-0539-01**  
17 **and budget in the amount of \$70,000.00 with an IDC amount of \$3,900.00 as attached,**  
18 **of which all recommend for acceptance by the Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **approves the First Things First Intergovernmental Agreement GRA-RC026-13-0539-01**  
21 **and budget as attached, which shall commence on July 1, 2012 and remain in effect**  
22 **until June 30, 2013, and may be renewed for two additional twelve month periods until**  
23 **June 30, 2015, based on performance and availability of funds, and authorizes the**  
24 **Chairman of the Nation to execute it.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairman and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level will be**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


