

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting August 22, 2012 Special Session to Address the 4th Millennium, Inc. Charter and  
Related Issues)**

LEGISLATIVE ORDER NO. 12-327

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and


5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with  
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the  
7 Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, the Commerce Committee has requested a special session on August 22, 2012 to  
9 address the 4th Millennium, Inc. charter and related issues.

10 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a  
11 special session on August 22, 2012 beginning at 1:00 PM to address the 4th Millennium,  
12 Inc. charter and related issues.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> day of  
14 AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
15 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article  
16 VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
17 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
19 Stat. 984).


