

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 3 to the Intergovernmental Agreement with the**  
**Arizona Department of Economic Security for FY2013 Low Income**  
**Home Energy Assistance Program (LIHEAP))**

RESOLUTION NO. 12-332

1 WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) services are provided  
2 through the Arizona Department of Economic Security, Intergovernmental  
3 Agreement, Contract No.DE111074001; and

4 WHEREAS, amendment No. 3 to the Intergovernmental Agreement has been received, deleting  
5 and replacing: Terms and Conditions, Fingerprinting section 32.1.1; and

6 WHEREAS, amendment No. 3 has been reviewed by the Executive Branch Attorney and the  
7 Nations' Attorney General's office; and

8 WHEREAS, the Health and Human Services committee and the Domestic Affairs committee have  
9 reviewed this contract amendment and recommend its approval and adoption.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves  
11 Amendment No. 3 to the Intergovernmental Agreement for the FY2013 LIHEAP  
12 program for the period beginning July 01, 2012 to June 30, 2013.

13 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs the  
14 Chairperson of the Nation to execute Amendment No. 3 substantially in the form  
15 attached hereto; provided however that any amendments affecting the contract  
16 amount shall be submitted for further prior approval by the Tohono O'odham  
17 Legislative Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day  
19 of AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
20 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section  
21 1 (d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
22 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).
