5	1996 and is compensated from the State of Arizona for the services; and
6	WHEREAS, the updated Intergovernmental Agreement (IGA-YH13-0004-007) will allow Tohono
7	O'odham Nation to continue long term care case management that the ALTCS Program
8	currently provides; and
9	WHEREAS, there weren't any substantial content changes to the document; the
10	processes/expectation related to Case Management remain the same with only minor
11	wording and formatting changes; and
12	WHEREAS, all future ALTCS Program client compensated funds received by the Division of Senior
13	Services shall be applied to the ALTCS base budget (600-6200) for current and future
14	program operations.
15	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
16	approves the updated Inter-governmental Agreement (YH13-0004-007) with minor
17	wording and formatting changes, and authorizes the Chairman of the Nation to
18	execute it.
19	BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of this
20	contract shall be submitted for further prior approval by this Council.
