3 **FY2012; and by Resolution No. 12-060 the Nation approved Amendment No. 1 to the**
4 **Attorney Contract with the law firm of Rusing Lopez & Lizardi PLLC funded by the**
5 **Economic Development Delegation Budget for FY2012; and**

6 **WHEREAS, the Attorney General recommends approval of Amendment No. 2 to the Attorney**
7 **Contract; and**

8 **WHEREAS, the Domestic Affairs Committee has reviewed Amendment No. 2 to the Attorney**
9 **Contract and recommends approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves Amendment No. 2 to the**
12 **Attorney Contract with the law firm of Rusing Lopez & Lizardi PLLC for FY2012**
13 **substantially in the form attached hereto.**
- 14 **2. The Chairperson of the Nation is authorized and directed to execute Amendment**
15 **No. 2 to the Attorney Contract.**

17 **of AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 2(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
20 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
