2 **of SNR Denton US LLP funded by the Economic Development Delegation Budget for**
3 **FY2012; and**

4 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**
5 **Contract; and**

6 **WHEREAS, the Economic Development Delegation and the Domestic Affairs Committee have**
7 **reviewed Amendment No. 1 and recommend approval by the Legislative Council.**

8 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 9 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**
10 **Attorney Contract with the law firm of SNR Denton US LLP for FY 2012,**
11 **substantially in the form attached hereto.**
- 12 **2. The Chairperson of the Nation is authorized and directed to execute the Attorney**
13 **Contract.**

15 **of AUGUST, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 2(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
18 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**


