LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Authorizing Execution of Sirius XM Radio, Inc. Agreement)

LEGISLATIVE ORDER NO. 12-343

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with the
2		$power to \verb ``negotiate and conclude agreements and contracts on behalf of the Tohono$
3		O'odham Nationwith private persons or organizations on all matters within the
4		authority of the Tohono O'odham Council" (Constitution, Article VI, Section 1 (f)); and (Constitution, Council VI) (Constitution, Council VII) (Constitution, Council
5	WHEREAS,	the Council has prescribed the duties and powers of the Council Chairman and Vice
6		Chairman (collectively, "legislative officers") by adopting the Legislative Rules and by
7		passing Legislative Order No. 06-047, "Amended Delegation of Authority to Legislative
8		Council Chairperson and Vice Chairperson"; and
9	WHEREAS,	although Legislative Order No. 06-047 expressly delegates to the legislative officers the
10		authority to negotiate, execute, and administer certain contracts, the officers are not
11		authorized to enter contracts that "indemnify a third party or authorize payment of
12	ļ	an award of attorney fees or costs of litigation or arbitration, unless previously
13		authorized by a majority vote of the Legislative Council"; and
14	WHEREAS,	the legislative officers seek to equip Legislative Branch vehicles with satellite radio
15		service and have negotiated an agreement with service provider, Sirius XM Radio, Inc.;
16		and
17	WHEREAS,	the Sirius XM Radio, Inc. Customer Agreement & Website Terms of Use (hereafter,
18		"Agreement"), which are incorporated by this reference, does not expressly require the
19	:	Legislative Branch to waive its sovereign immunity or legislative immunity but does
20		include an indemnification clause, arbitration clause, and other provisions which
21		require Legislative Council approval.
22	NOW, THE	REFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it authorizes
23	·	the legislative officers to enter into the Sirius XM Radio, Inc. Agreement, provided that
24		nothing in this delegation or in the Agreement shall be deemed a waiver of the Nation's
25		sovereign immunity or legislative immunity
26	The forego	oing Order was passed by the Tohono O'odham Legislative Council on the <u>29TH</u> day of
27	AUGUST. 2	012 at a meeting at which a quorum was present with a vote of 1,629.0 FOR; 1,151.60
