9	reference; and
10	WHEREAS, pursuant to Article VIII, Section 1(C)(1) and (2) of the Enrollment Ordinance,
11	The final determination as to whether an application for enrollment o
12	adoption is approved or rejected by the Council shall be reduced to writing an
13	approved by the Chairman of the Nation regarding each application fo
14	enrollment or adoption filed with the enrollment committee. Such determinatio
15	shall set forth the following findings of fact:
16	(1) If on an application for adoption, the date of applicant's birth, the degree of
17	Papago-Tohono O'odham Indian blood ascribed to the applicant.
18	(2) If on an application for enrollment, the date of applicant's birth, th
19	membership requirement or requirements which the Council found th
20	applicant did or failed to establish.
21	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewe
22	the Enrollment Committee's recommendations and approves the applications fo
23	enrollment or adoption that are identified in the September 2012 Membershi
24	Applications List, which includes the name, date of birth, enrollment number, an
25	membership requirement or, for adoption, the degree of Papago-Tohono O'odhai
26	Indian blood for each applicant.
27	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10 TH Da

of <u>SEPTEMBER</u>, <u>2012</u> at a meeting at which a quorum was present with a vote of <u>2,780.60</u> FOR; <u>-0-AGAINST</u>; <u>-0-NOT VOTING</u>; and <u>[02]</u> ABSENT, pursuant to the powers vested in the Council by Article II, Section 1 (<u>a)or(b)</u> and Section 2 and Article VI, Section 1 (<u>h)</u> of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
