Amount of \$541,000.00)**

RESOLUTION NO. 12-352

1 WHEREAS, on July 26, 2012, the Sif-Oidak District Council passed Resolution No. SODC-12-092,
2 "Approving the Sif-Oidak District FY 2013 Community Services Budget in the Amount
3 of \$541,000.00"; and

4 WHEREAS, the funding is being requested out of the Mining Funds held by the Tohono O'odham
5 Nation on behalf of the Sif-Oidak District; and

6 WHEREAS, the Legislative Budget and Finance Committee did review the proposed Community
7 Services Budget and recommends approval.


8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby
9 approve the Sif-Oidak District FY 2013 Community Services Budget in the amount of
10 \$541,000.00.

11 BE IT FURTHER RESOLVED that the funding amount of \$541,000.00 will be taken out of the Mining
12 Funds held by the Tohono O'odham Nation Treasury on behalf of the Sif-Oidak District.

13 BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding
14 levels that it shall be approved by the Tohono O'odham Legislative Council prior to any
15 expenditures.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
17 of SEPTEMBER, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
18 AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
19 Article VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the
20 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
22 18, 1934 (48 Stat. 984).
