10	159 to include the feasibility studies for the Bob's Market expenditures".

13	<b>\$150,000</b> .
14	BE IT FURTHER RESOLVED that the funding will come out of the Sif-Oidak District Economic
15	Development Investment Account.
16	BE IT FINALLY RESOLVED that in the event there should be any further changes in the funding or
17	funding levels that it shall be approved by the Tohono O'odham Legislative Council
18	prior to any expenditures.
